Commencement

This correction sheet for the national part of the curriculum from August 2018 applies to all students who were admitted to the programme on 15.08.2018 and applies to students who are admitted to the programme on the stated date, or later.

Changes to the National Part of the curriculum

The corrections concern the following sections:

- 2.10, description of subject element Nature programme specialisation Environmental and nature management (10 ECTS)
- 2.11, description of subject element Environment programme specialisation Environmental and nature management (10 ECTS)
- 2.12, description of subject element Management and administration programme specialisation Environmental and nature management (10 ECTS)

The changes affect two different sections:

- 1. The subject element 2.10, and 2.11 must be weighted 15 ECTS instead of 10 ECTS.
- 2. The subject element 2.12 is not included in the national part, but is a part of the institutional part of the curriculum, where it can be found in section 2.4 Study programme Nature and Environment under the study programme 'Environmental Management'.

The subject element environment is weighted 10 ECTS credits.

ECTS weight

The subject element nature is weighted 15 ECTS credits.

2.11. Environment - study specialisation nature and environment

ECTS weight

The subject element environment is weighted 15 ECTS credits.

2. About subject elements, which were mistakenly included in the national part and must only be in the institutional part of the curriculum

Original formulation:

2.12. Management and administration - study specialisation nature and environment

Content

The subject element deals with basic knowledge of management and the administration of environmental and nature conditions in relation to the production and use of resources, as well as other activities. Work will be done with analysis, evaluations and the apparatus in relation to nature and environmental management. Work will also be done with concrete solutions for practice-orientated and complex problem statements

Learning objectives for management and administration

Knowledge

The student will gain knowledge about:

- the public administration's set-up, processing and apparatus
- business partners and stakeholders outside of public administration and their scope.

Skills

The student will get the skills to:

- evaluate practice-orientated and complex problem statements in a larger perspective based on the relevant legislation
- design project proposals and evaluate their effect by applying the subjects central methods and legislation
- suggest care methods, techniques and equipment, as well as evaluate the economy.
